**ADDENDUM  
TO FIFTEENTH SUPPLEMENT TO COMMUNITY CHARTER FOR LEGACY**

THIS ADDENDUM is made this 20<sup>th</sup> day of April 2017, to that certain Fifteenth Supplement to Community Charter for Legacy (the "**Fifteenth Supplement**"), which Fifteenth Supplement is recorded as Instrument No. 2017-000524, Ada County Records, and which Community Charter for Legacy ("**Charter**") is recorded as Instrument No. 108048693, Ada County records.

**Recitals**

A. The Fifteenth Supplement added Snoqualmie Falls Subdivision No. 8, Ada County, Idaho ("**Phase 8**") to the property subject of the Charter.

B. Pursuant to that certain Amended and Restated Joint Maintenance of Median Strips (Parkways) in Legacy (the "**Joint Maintenance Agreement**"), recorded as Instrument No. 2016-096206, records Ada County, Idaho, the maintenance of the Median Strips (defined in the Joint Maintenance Agreement) was allocated between each owner of a home site (a "**Unit**") and the Legacy Community Association of Legacy, Inc. (the "**Association**").

C. The Joint Maintenance Agreement was recorded prior to the platting of Phase 8.

NOW, THEREFORE, in consideration of the recitals set forth above, and the covenants and conditions contained in the instruments referenced above, the undersigned, Brahma, LLC, an Idaho limited liability company, hereby declares that the Association and the owners of all Units in Phase 8 shall share in the maintenance of the Median Strips in accordance with the Joint Maintenance Agreement, and all such Units shall be subject to said Joint Maintenance Agreement.
